## CAMPUS ASSEMBLY POLICY

## 1.0 POLICY STATEMENT

The University of Alaska Fairbanks is committed to academic freedom, freedom of speech, petition and assembly. These are fundamental to the democratic process, and fundamental to the academic mission of the university.

UAF makes clear that these freedoms are to be exercised in a manner that protects the rights of all members of the campus community. UAF reserves the right to determine the time, place and manner of assembly or presentation in order to assure the continuation and quality of the educational process, the protection of property, and the health and safety of our campus community.

## 2.0 **DEFINITIONS**

## TIME, PLACE AND MANNER:

University of Alaska Fairbanks defines time, place and manner restrictions as limitations on when, where and in what manner expressive rights can be exercised, which are congruent with the right to freedom of expression provided that the limitations are justified without reference to the content of the regulated speech; that they serve a significant governmental interest; and that, in so doing, they leave open ample alternative channels for communication of the information. The conclusion of the activity must be documented on the advance registration materials submitted by groups.

7. Nothing in this policy shall guarantee any group or individual exclusive use of university property for free expression activities.
