## Guidance on Faculty Governance

- 1) Election of the Faculty Senate

- 2) The Dean/Director's Office should inform the Faculty Senate of the following:
  - Tenure-track, research, and other appointments
  - Faculty Senate, and may participate in the process of joint appointments
  - Faculty Senate should be notified of all appointments, including joint appointments
  - primary appointments are determined as follows:
    - Faculty with joint appointments (with other units) are represented in the Faculty Senate by the unit in which they are primarily appointed
    - Faculty with joint appointments (with other units) should be represented in the Faculty Senate by the unit in which they are primarily appointed
  - In accordance with the Faculty Senate's policies, the Dean/Director's Office should inform the Faculty Senate of all appointments, including joint appointments
  - Faculty with joint appointments should be represented in the Faculty Senate by the unit in which they are primarily appointed
- 3) The Dean/Director's Office should inform the Faculty Senate of the following:
  - Faculty with joint appointments (with other units) are represented in the Faculty Senate by the unit in which they are primarily appointed
